WRS Contribution Rates to Decrease in 2018

Contributions paid by Wisconsin Retirement System employees will decrease slightly for most individuals, effective January 1, 2018.

Total 2018 contribution rates, expressed as a percentage of salary, are indicated in the table below.

WRS Required Contribution Rates

Note: Rates for other mandatory employer-paid contributions for duty disability, the state's Accumulated Sick Leave Conversion Credit Program, or unfunded liabilities are not included in the above figures, as they vary by employer.

The 2018 rate changes are primarily due to higher favorable WRS Trust Fund investment performance. In general, when trust fund investment earnings are greater than expected, contribution rates may decrease the following year. When earnings are lower than expected, rates may increase to make up for the shortfall.

Changes in WRS contribution rates are designed to be stable, with investment returns for the Core Fund smoothed over a five-year period.

WRS contribution rates are set annually by the ETF Board, upon review of its consulting actuary's annual valuation of the system and its funding requirements. The total rates are generally split evenly between employees and employers and adjusted annually. Contributions are paid in full, ensuring full funding of future WRS benefits.

- ♥ 2 cups all-purpose flour
- V 2 cups quick-cooking rolled oats
- V 1 /2 cups firmly packed brown sugar
- V I teaspoon baking soda
- V /2 teaspoon saft
- V 1 1/4 cups margarine or 1 1/4 cups butter, softened

V Flung

- ∇ 1 (12 1/2 ounce) jar caramelice cream topping (1 cup)
- ♥ 3 tablespoons all-purpose flour
- √ I (b ounce) package semi-sweet chocolate
 chips (I cup)
- V 2 cup chopped nuts

DIRECTIONS

- 1. Heat oven to 350*.
- 2. Grease 13x9 inch pan.
- 3. In large bowl blend all crust ingredients at low speed until crumbly.
- 4. Press half of crumb mixture, about 3 cups, in bottom of greased pan
- 5. Reserve remaining crumb mixture for topping.
- 6. Bake at 350^* for 10 minutes.
- 7. Meanwhile, in small bowl combine caramel topping and 3 tols. flour; set aside.
- 8. Sprinkle warm crust with chocolate chips and nuts.
- 9. Drizzle evenly with caramel mixture; dollop with reserved crumb mixture.
- 10. Return to oven and bake an additional 18 to 22 minutes or until golden brown.
- 11. Cool completely.
- 12. Refrigerate 1 to 2 hours or until filling is set.
- 13. Cut into bars. Yield 36 bars
