Employee Trust Funds Board Announces 2017 WRS Contribution Rates

At its June 23, 2016 meeting, the Employee Trust Funds Board approved Wisconsin Retirement System contribution rates for 2017, including rates for Wis. Stat. § 40.65 protective occupation duty disability and the State Accumulated Sick Leave Conversion Credit Program (state employers only). These rates are based on current benefit levels and recommendations from the Board's independent consulting actuary.

WRS Employment Category	Contribution Rate Change:	
General, Teachers and Educational Support Personnel; Executive, Elected and Judges	Increase 0.4%	
Protective with Social Security	Increase 1.4%	
Protective without Social Security	Increase 1.9%	

Employers who have either elected to increase prior service coverage or pay off their unfunded liability balances may also experience a change in their prior service rates.

Factors Impacting WRS Rates

There are many complex factors that affect WRS contribution rates, such as investment performance, legislative adjustments to benefit levels, demographics, etc. It is important to remember, WRS investment experience is smoothed over a course of five years to prevent large swings in WRS contribution rates.

WRS rates are increasing in 2017 due to increases in life expectancy and low investment returns.

2011 Wisconsin Acts 10 and 32 in most cases prohibited WRS employers from paying the employee-required portion of the WRS contribution. The 2017 rate change will be split equally between the employee and employer for general employees, executives, elected officials and judges for 2017. Act 10 requires that the employee-required contribution for protective occupation employees be equal to the employee-required contribution for general employees.

The annual actuarial valuation incorporates current economic and demographic data into the existing financial condition of the WRS in order to set new contribution rates for the system. It is normal for contribution rates to fluctuate somewhat from year to year, based on investment earnings, wage inflation and demographic trends. In addition, the change in contribution rates may vary between employment categories, depending on varying demographic trends within those groups. Benefits being paid to current annuitants are not affected by these rate changes.

LOUISIANA — A new law goes into effect Monday, August 1, 2016, that expands Louisiana's hate crime statute to include the targeting of police officers, firefighters and EMS personnel,

The bill, Act 184, is also called the Blue Lives Matter bill.

The bill was passed weeks before three officers were killed and three others were injured in an attack on a Baton Rouge highway. An ex-marine ambushed the officers after reportedly spending days planning his attack.

The Baton Rouge ambush followed on the heels of the Dallas, Texas, attack on officers, both cases involving skilled gunmen and multiple casualties.

Under the new law, if a defendant is convicted of a hate crime, they could face additional penalties, more time in prison and fines.

Louisiana was the first state to add one's chosen vocation to the hate crime list, Prior hate crimes were considered as such if the victims were targeted for their race, ethnicity, religion, gender or sexual orientation.

Easy Garlic Cheese Bombs Recipe - biscuit bombs filled with gooey mozzarella brushed with garlic Ranch butter and baked into perfection. Easy, fast and absolutely addicting!

ingredients

- 1 tube of biscuits (10 count); I used regular size
- 3 oz. mozzarella cheese, in brick
- ¼ cup salted butter, melted
- 2 teaspoons dry Ranch seasoning mix
- 2 teaspoons garlic powder or 3 teaspoons minced garlic

Easy Garlic Cheese Bombs

instructions:

- 1. Preheat oven to 400 degrees F.
- Line a baking sheet with silicone baking mat or parchment paper. Set aside.
- 3. Cube cheese into 3/4" pieces.
- Open biscuits and place on cutting board.
- Place one piece of mozzarella cheese in the middle of each biscuits. Pinch seams to close the cheese inside and form rolls.
- Place rolls on baking sheet, spacing them about 2" apart.
- 7. Mix melted butter with garlic and Ranch seasoning. Brush rolls with butter.
- Bake cheese bombs for 13 to 15 minutes OR until golden brown on top.
- 9. When done, brush rolls with remaining butter and let cool for 5 minutes.
- Serve warm with a side or marinara sauce for dipping.



the Perfect Fall Potpourri



- the peel of one orange
- 1 cut up apple
- 2 large cinnamon sticks
- 1 tablespoon of cloves
- 1 tablespoon of vanilla extract
- 1 tablespoon of almond extract
- 1 1/2 cups of water plus plenty more for refill

Place all ingredients in a cooking pot and simmer throughout the day while adding a bit of water from time to time. Also, you can reuse this mix for three days and store it in the fridge overnight.

Pumpkin Spice Latte Recipe

Total Time: 5-10 minutes

Serves: 1-2

Ingredients:

- 1 cup coconut milk
- 2 tbsp pumpkin
- 1 tbsp maple syrup
- 1/4 tsp pumpkin pie spice
- 1/4 tsp vanilla extract
- 1/4 cup organic brewed coffee or espresso

Directions:

- Combine the coconut milk, pumpkin, maple syrup, pumpkin pie spice and vanilla in a small pan over medium heat until the milk is hot
- Whisk vigorously to get the milk foamy for about 30 seconds.
- Pour the espresso or coffee into a large mug and add the coconut milk mixture.
 Sprinkle with a little extra pumpkin pie spice and serve.
