Balloting Period for Non-School District Non-State Annual Certification Elections Set for April 1-21, 2015

The Wisconsin Employment Relations Commission announced that annual certification election balloting regarding school district unions and State of Wisconsin employee unions will be held from noon on Wednesday, April 1 through noon on Tuesday, April 21, 2015. Petitions and appropriate filing fee must be received by WERC no later than January 30, 2015.

Voters who choose to vote by telephone will do so by calling 1-866-458-9862 (toll free) anytime between noon on Wednesday, April 1 through noon on Tuesday, April 21, 2015. After providing information that will allow the computer to verify that the employee is an eligible voter (the first four letters of last name and the last four digits of social security number), the employee will be asked "Do you want to continue to be represented by (the name of your current union) for the purpose of collective bargaining?" The employee will then be instructed on how to vote "yes" or "no" and asked to confirm his or her choice. After confirming his or her choice, the employee's vote will be electronically cast. The employee must confirm his or her choice for the vote to be cast. Employees experiencing trouble using the telephonic voting system can call 1-800-529-5218 during the hours of 10:00 am to 6:00 pm Monday-Friday.

Balloting periods regarding 2015 school district and State annual certification elections will be announced at a later date.

Birdfeeders

ingredients:

2 packets Knox gelatin 2/3 cup water 2 cups bindseed cooking spray cookie cutters/molds wax or parchment paper straws

twine

In a small saucepan, add gelatin to water. Stir until dissolved. Turn burner onto medium heat. Stir constantly until gelatin simmers. Remove pan from heat. Stir in 2 cups of birdseed until well incorporated. Let cool a few minutes. Line baking sheet with parchment/wax paper. Spray the insides of the cookie cutters/molds. Carefully spoon birdseed mixture to the top of each cutter. Insert a straw 1/2' from the top to create a hole for hanging. Place cookie sheet in the fridge for 1 hour or until solid. Remove cookie cutters and straw. insert twine and tie a knot. Makes 2 bird feeders approximately 4" wide.

Great Gardens!

Hydrangeas (Hydrangea spp.) produce bountiful, globular blooms that range from red to varying shades of pink to white. With the right soil, hydrangeas produce blue to lavender-blue blooms. Coffee grounds are one way to create soil that supports the growth of more unusual-colored hydrangea blooms. Before you swing by your coffee shop to pick up pounds of grounds, understand the process to help your hydrangea produce blue blooms.

Turning the flowers blue with coffee grounds isn't necessarily a quick process. Some hydrangeas grow flowers on last year's growth; other hydrangeas grow them on the current year's growth. Flower buds typically begin to develop on hydrangeas that are 2 or 3 years old, depending on the species and cultivar. The buds develop during the winter and continue to develop in spring, producing full blooms in late summer to early fall. As a result, the earlier you add coffee grounds to the soil, the earlier you impact the bloom color of the hydrangea, assuming it's old enough to bloom.

Coffee grounds also help retain moisture in the soil, which is an additional benefit to your hydrangea. Hydrangeas grow best with deep weekly watering rather than light daily watering and the coffee grounds help keep the soil moist between watering times. If you have azaleas and rhododendrons in your garden, as well as hydrangeas, these plants also respond well to a more acid soil, providing further use for your used coffee grounds.

If you have ever been in charge of the deviled eggs for your family picnic, you know that shelling a dozen hard boiled eggs can be a real chore. And did you know that the fresher your egg, the harder it is to peel? For easy peel hard boiled eggs, there is a fool-proof and simple trick to make shelling super easy – just add baking soda!

The egg white, also known as the *albumen*, sticks to the shell of fresh eggs after they are cooked. As the egg ages, however, it will not stick quite as much to the shell after cooking. The trick to easy shelling – add 1/2 tablespoon of baking soda to the cold water before boiling the eggs. When the water boils over the eggs, the baking soda will pass through the eggshell causing the egg white to separate from the shell.

So for easy-to-peel hard boiled eggs, just add baking soda to the water and the shell will come right off.
