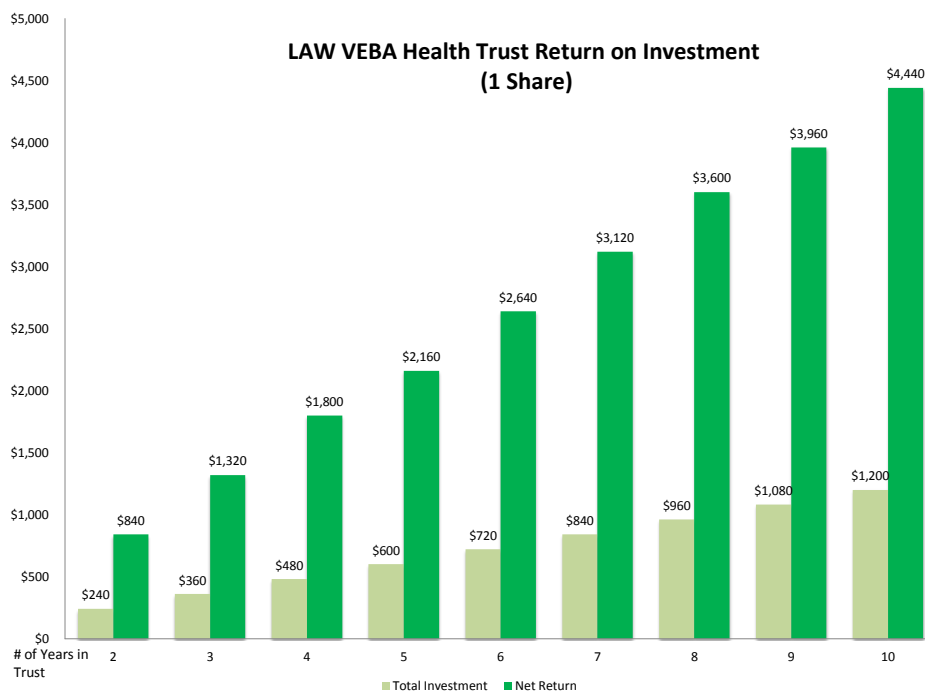

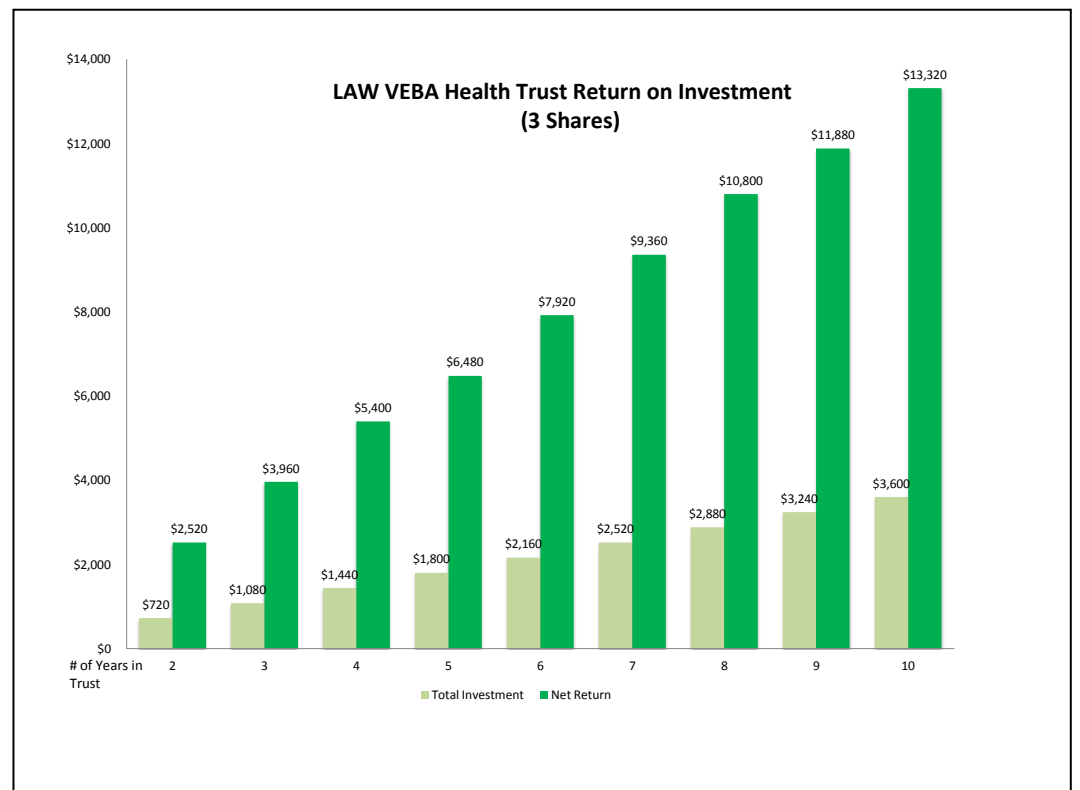
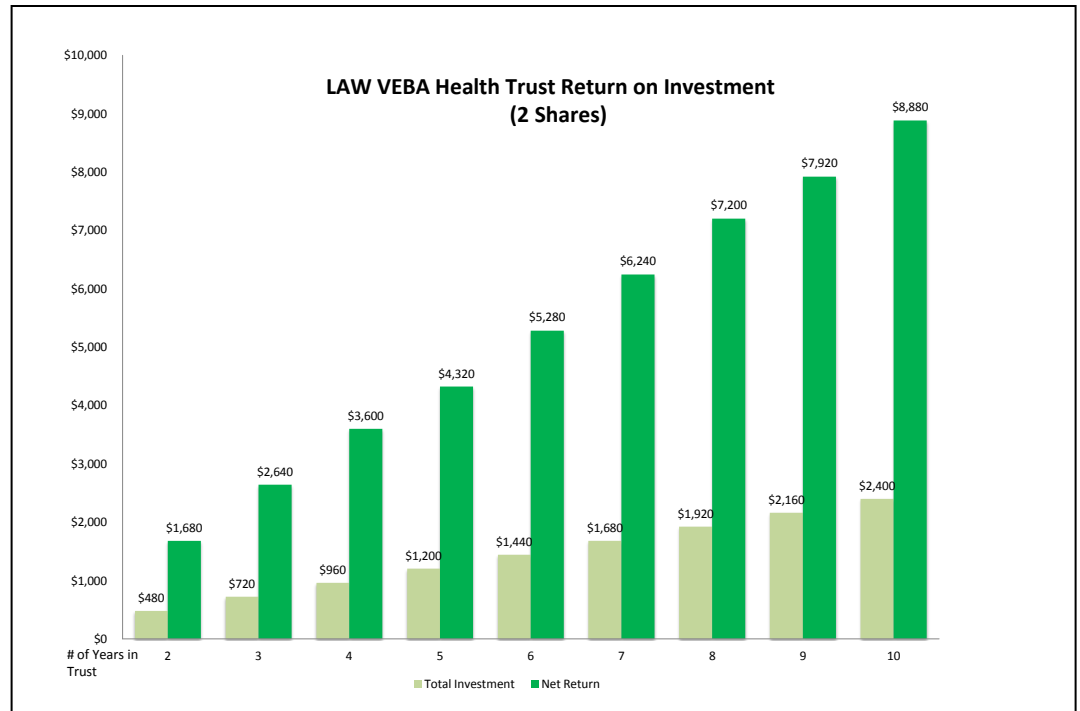

EARLY FOURTH OF JULY CELEBRATIONS

In the pre-Revolutionary years, colonists had held annual celebrations of the king's birthday, which traditionally included the ringing of bells, bonfires, processions and speechmaking.

By contrast, during the summer of 1776 some colonists celebrated the birth of independence by holding mock funerals for King George III, as a way of symbolizing the end of the monarchy's hold on America and the triumph of liberty. Festivities including concerts, bonfires, parades and the firing of cannons and muskets usually accompanied the first public readings of the Declaration of Independence, beginning immediately after its adoption. Philadelphia held the first annual commemoration of independence on July 4, 1777, while Congress was still occupied with the ongoing war.

George Washington issued double rations of rum to all his soldiers to mark the anniversary of independence in 1778, and in 1781, several months before the key American victory at Yorktown, Massachusetts became the first state to make July 4th an official state holiday.

After the Revolutionary War, Americans continued to commemorate Independence Day every year, in celebrations that allowed the new nation's emerging political leaders to address citizens and create a feeling of unity. By the last decade of the 18th century, the two major political parties—Federalists and Democratic-Republicans—that had arisen began holding separate Independence Day celebrations in many large cities.

JULY 4TH BECOMES A NATIONAL HOLIDAY

The tradition of patriotic celebration became even more widespread after the War of 1812, in which the United States again faced Great Britain. In 1870, the U.S. Congress made July 4th a federal holiday; in 1941, the provision was expanded to grant a paid holiday to all federal employees. Over the years, the political importance of the holiday would decline, but Independence Day remained an important national holiday and a symbol of patriotism.

Falling in mid-summer, the Fourth of July has since the late 19th century become a major focus of leisure activities and a common occasion for family get-togethers, often involving fireworks and outdoor barbecues. The most common symbol of the holiday is the American flag, and a common musical accompaniment is "The Star-Spangled Banner," the national anthem of the United States.

DID YOU KNOW?

John Adams believed that July 2nd was the correct date on which to celebrate the birth of American independence, and would reportedly turn down invitations to appear at July 4th events in protest. Adams and Thomas Jefferson both died on July 4, 1826—the 50th anniversary of the adoption of the Declaration of Independence.

Switching Keyboard Quickly

When you want to type a *single number*, it is inconvenient to switch to numbers, type one number and then switch back to normal keyboard. If you *press and hold the number key* (lower left hand corner) and then slide to the number and lift your finger off, it will type the number and automatically switch back to previous keyboard

Stop call from ringing/Send call to Voicemail.

When you want to stop a call from ringing, press the on/off (power) button once; to send the call to voice mail press the on/off (power) button twice.

Quick access the camera without unlocking iPhone

Press the "Home" button once, place finger on camera icon (lower right hand corner) and swipe up. Access other apps in this same manner as in accessing camera by swiping up in the *middle* of the phone.

Invert your colors for better nighttime browsing.

Inverting your colors will turn the screen black and the text white for less eye strain. Go to Settings > General > Accessibility. Turn on "Invert Colors."

Outsmart your autocorrect by typing an extra letter when trying to spell a contraction.
